WE DO THIS BY FACILITATING DIALOGUE AMONG THE NATIVE AMERICAN TRIBES THAT HAVE RESIDED ACROSS THIS LANDSCAPE FOR THOUSANDS OF YEARS, AND WHO NOW CONTROL THE FUTURE OF SOME 30,000 SQUARE MILES OF THIS REGION.

VOLUNTEER SUPPORT HAS A RIPPLE-OUT EFFECT WITH BENEFITS FOR OUR ORGANIZATION, OUR EXTERNAL PARTNERS, AND THE VOLUNTEERS THEMSELVES. THE IMPACTS OF VOLUNTEER CONTRIBUTIONS ARE FAR-REACHING, AS WE SUPPORT AGENCIES AND PARTNERS WHO ARE STRETCHED THIN, ESPECIALLY DURING THE DOI AND USDA DOWNSIZING IN 2025. THIS IS ALL THE MORE IMPORTANT AS GRAND CANYON NATIONAL PARK PIVOTS TO WORKING EXCLUSIVELY WITH TRIBAL LEADERS INSTEAD OF GRASSROOTS LEADERS TO MANAGE A LANDSCAPE WITH COMPLEX HISTORIES WHERE COMMUNITY AND CULTURAL VOICES ALSO MATTER. BUT THE MOST SIGNIFICANT GRAND CANYON-RELATED WORK IN 2025 WAS RESPONDING TO THE AFTERMATH OF THE DRAGON BRAVO AND WHITE SAGE FIRES, WHICH BURNED ACROSS 200,000 ACRES OF THE NORTH RIM AND NEARLY OVERTOOK KANE RANCH. WE ENGAGED READILY WITH AGENCY STAFF AND OTHER PARTNERS TO TRACK DAMAGE AND BEGIN PROACTIVE PLANNING FOR THE REBUILD AND RESTORATION OF THE AREA. WE ARE WORKING TO SUPPORT A REBUILDING PROCESS THAT INCLUDES TRIBES AND NATIVE BUSINESSES AND THAT IS LOCALLY INFORMED.

PUBLIC LANDS:

THESE EFFORTS CONTINUE TO BUILD ON CPIC'S FOUR MAIN PILLARS OF FOCUS: HEALTH, SACRED SITES, WATER, AND LANGUAGE & CULTURE.
